18 people attended

Not native to North America. Found in US in Detroit in 2002
Only effects Ash Trees – White, Green(Red), Black
Compound alternate leaves, opposite branches. Bark is unique – "diamondish"
Top 10 trees it's # 9, about 3% of the forest
Millions of trees have been lost.
There are 40 different insects solely dependent on ash trees.

Majority of time the EAB lives inside the tree.

Small D-shaped adult exit holes

Arrived in CT in 2008 or 09 and found in 2012 in Prospect.

Most likely spread in firewood because the wood is kept for a period of time to season. Non-stinging wasp Cerceris will paralyze its prey, take it home and lay eggs on it for food for the larvae. They prey on beetles like the EAB. Like sandy soil. The wasps are very tiny.

All firewood is regulated because it's hard to pick ash out of a wood pile.

Self issued permit free on the website to confirm source of firewood when moving within CT. To bring into CT, need signed by higher authority.

Asian Longhorn Beetle ALB infests maple, birch, and elms.
